#### 1. Qualifications for Submission

Conditions for Fulfillment:

- (1) Persons with over seven years experience of research in the agriculture field after graduating from a four-year undergraduate program, or persons with over four years experience of research in the agriculture field after completing a master's program.
- (2) Persons who have withdrawn from our doctoral program but have attended for more than three years and have earned 12 credits.
- (3) Persons who have graduated from a technical college (under the old education system) or a two-year college with over ten years experience of research in agriculture.
- (4) Persons who do not apply to the conditions in (3) above and who have passed the eligibility review for doctoral dissertation application (hereinafter referred to as "eligibility review").
- (5) In addition to fulfilling the conditions above, the following requirements must be fulfilled:

Preparation of at least four academic papers (independent papers or primary authorship of co-authored papers) as "basic background papers"

(6) The basic background papers indicated in (5) above must have been published or accepted by a scientific journal with an established system of review. ("Scientific journal" refers to a journal published by an academic or similar society able to nominate candidates to membership in the Science Council of Japan, or an internationally acknowledged scientific journal published by an academic or similar society outside Japan.)

In addition, previously presented papers, in principle, must be submitted to the same level of scientific journals as above.

# Recognition Standards for Scientific Journals Whose Articles will be Used as a Prerequisite for Doctoral Dissertations:

I. Scientific Journals

Scientific journals whose articles will be used as a prerequisite for doctoral dissertations must satisfy the conditions below.

- 1. The articles in the journals must be written in Japanese or English, or both.
- 2. The journals must have a referee system.
- 3. The journals must satisfy one or more of the followings.
  - a. Journals listed on Web of Science Core Collection
  - b. Journals listed on Current Contents Connect, Web of Science
  - c. Reviews in Agricultural Science: organized, edited and published by all-Japan UGSAS groups.
  - d. Journals published by groups that are listed in the 19th Session of Registered Research Groups by the Science Council of Japan or their renamed successor groups.
  - e. Journals other than a. to d. above which are recognized by the Board of Representatives and publicly announced by UGSAS.
- II. Additional recognition of scientific journals whose articles will be used as a prerequisite for doctoral dissertations:
  - 1. Only qualified academic supervisors can apply to add journals which satisfy the condition I.3.e. above. Those who apply will be required to submit the evidence which proves that the journals satisfy II.2 or II.3 below.
  - 2. In order to add a scientific journal published by an academic research group which has its primal base in Japan to the scientific journals satisfying I.3.e. above, the academic research group must satisfy all of the followings and be evaluated appropriate by the Board of Representatives after hearing from two or more expert committee members.
    - a. Name, purpose, office location, qualifications of active members and the representatives of the group must be provided.
    - b. The group's activities and achievements in relation to the improvement and development of scientific research must exceed three years.
    - c. Active members must be 200 or more scientists.
    - d. Meetings for presentations and discussions on scientific research by the active members must be held once or more a year.
    - e. Journals for the presentation of academic research must be published once or more a year.
    - f. General meeting or other equivalent meetings to determine the administrative and action policy of the group must be held once or more a year.
    - g. Requirements to be an active member must not be restricted to individuals who live or

work in a specific region.

3. In order to add a journal which does not satisfy II.2. above to the journals recognized under I.3. e. above, the Board of Representatives must unanimously evaluate the journal as a suitable one to publish academic papers that form the basis of the dissertation on it after hearing from two or more expert committee members.

#### III. Expert committee members

The expert committee members mentioned in II, who are appointed by the Borad of Representatives, shall be selected from the qualified academic supervisors whose fields of expertise are close to those of the journal. One of the expert committee members must be a member of the Board of Representatives.

#### IV. Period of Validity

This agreement is applied from the degree application completing in March 2008.

Supplementary Provisions (Board or Representatives, August 1st, 2023) This agreement shall come into effect on August 1, 2023.

#### Reference

When applying to add a journal that does not satisfy II. 2. as a newly recognized scientific journal whose article will be used as a prerequisite for doctoral dissertation review, the following information regarding the journal is generally required to be reported.

- 1. Name of the journal
- 2. Publishing parent organization: If it is an academic association, add information on the association.
- 3. Publishing company (country)
- 4. History: number of years of publications, cumulative number of publications
- 5. Annual number of publications and dissertations
- 6. Referee system
- 7. Members of Editorial Board
- 8. Whether or not there is any restrictions of contributors; if it is an international journal, whether or not there is a bias toward particular countries.
- 9. The database (index) the journal has been registered for
- 10. (If available) Acceptance rate
- 11. (If available) Average period of time from submission to acceptance of about previous 10 papers. Information on the deviation between the length of period may be added.

- 12. (If available) Correspondence during referee reading
- 13. Cost of submission and publication
- 14. Comments by the applicant

#### 2. Submission Period

Applicants may submit their applications at any time.

#### 4. Submission Method

- A. Dissertation and Other Documents to be Submitted
  - Documents must be submitted directly at the office of the United Graduate School of Agricultural Science, Gifu University (the UGSAS Office), or by registered mail *(kakitome)*.
- B. Dissertation Evaluation Fee
  - Applicants will be required to pay a fee of 57,000 yen. Remit payment by order of the UGSAS Office.
  - For those who have withdrawn from the Ph.D. program after studying beyond the standard term (three years) will be required to pay a fee of <u>57,000 yen when more than one year has</u> passed since the student has withdrawn from the program. Remit payment by order of the UGSAS Office.
  - Once paid, the evaluation fee will not be returned.
- C. All dissertation submissions must be approved by the recommending professor of the United Graduate School of Agricultural Science.

#### 5. Rules for Preparation of Dissertation

#### A. Dissertation


- (1) Dissertations may be submitted in either Japanese or English.
- (2) Materials should be submitted on A4 size paper, double-spaced (typed, 24 to 26 lines per page), with 2.5 to 3 cm margins on all sides.
- (3) The <u>front cover</u> and the spine of the bound dissertations should indicate the dissertation title (if in English, include Japanese translation on the format cover), year of submission (Western calendar), and name of the author. The name of the United Graduate School should be indicated on the cover above the name of the author (see below).
- (4) If photocopied, the copies should be one-sided only and should be able to endure long-term preservation.
- (5) The bound dissertations should have the following format:(See p. 13)
  - a. A black cover
  - b. Gold lettering
  - c. English title like below:

- (6) On the first page, the dissertation title and the name of the author should be indicated, and the Table of Contents should continue on the next page.
- (7) In principle, the text should follow in the order of Introduction, Materials and Methods, Results, Discussion, Conclusion, Acknowledgements, and References.

(8) Numerical values shall be used for calculation, and SI units (international unit system) should, in principle, be used for units (see JIS Z8202 and JIS Z8203, published by the Japanese Standards Association).

- (9) The list of references shall be numbered and arranged in the order of citation. They should be cited as "(1)" and "(2–4, 7)", or "[1] and "[2–4, 7] in the text. Details in the list of references should be as follows:
  - a. For journals: author name (all authors), title, journal name, volume and first–last page number. (DOI identifiers if necessary.)
  - b. For books: author name, title, edition, pages cited, year of publication, publisher, and place of publication.
  - c. For contributory works: author name, title of chapter, editor, title of publication, edition, first–last page number, publisher, and place of publication.

Journal abbreviations should refer to *the Igaku Chuo Zasshi*, ISO 4 (Information and documentation –Rules for the abbreviation of title words and titles of publications), etc.

B. Academic Papers that form the basis of dissertation and Previously Presented Academic Papers

- Academic Papers that form the basis of dissertation should be collected in one volume, provided with a temporary binding at the left margin, and clearly indicated on the cover as Academic Papers that form the basis of dissertation above the name of the author. (See p. 14)
- (2) Previously presented academic papers should be collected in one volume, provided with a temporary binding at the left margin, and clearly indicated on the cover as previously presented academic papers above the name of the author. (See p. 15)
- C. Dissertation Summaries (Form No.3)
  - (1) Dissertation summaries should be in Japanese (approximately 2,000 characters) or in English (approximately 1,200 words).
  - (2) Summaries should be typed using the designated format. (See p. 19) Prepare 1 copy and PDF(PDF/A).

#### D. Dissertation Submission

Submit one bookbinding dissertation and its PDF (PDF/A) by the day before the degree acquisition (or the designated day by the UGSAS Office) after your degree has been determined by the committee. In case you make corrections or revisions after submittion, be sure to submit the new version and its PDF by 17:00 of the day before the Graduate course Committee meeting. If not, the old version will be registered on the Gifu University Institutional Repository.

6. Dissertation Evaluation and Final Examination / Evaluation of Academic Ability

#### A. Procedures for Dissertation Evaluation

- The submitted dissertations will be officially accepted after the Committee of Professors (Board of Representatives) has evaluated if the applicants have fulfilled the qualifications for submission and all the necessary documents have been submitted.
- (2) The Committee of Professors (Board of Representatives) will form an Evaluation Committee per dissertation after it has been officially accepted.
- (3) The Evaluation Committee consists of <u>one chair</u> and <u>two or more deputy chairs</u>. The <u>chair of Dissertation Doctorate</u> must be the recommending professor (qualified to be a primary academic supervisor) of the dissertation. <u>Deputy chairs</u> must be, in principle, faculty members who are qualified as primary academic supervisors (if needed, also can include faculty members who are qualified for secondary academic supervisors, except for lecturers can be included) and include professors from each participating universities.
- (4) The Committee of Professors (Board of Representatives) can add additional professors/researchers as Evaluation Committee members from other Gifu University graduate programs, other universities' graduate programs, research institutes, and graduate programs or research institutes abroad if particularly necessary.
- (5) The Evaluation Committee will hold a dissertation defense open to the public conducted by the chair at the participating universities where the chair is positioned.
- (6) Dissertation defense consists of oral presentation by the applicant (in principle, presented in Japanese or in English) and followed discussion.
- (7) The Evaluation Committee will announce to each participating universities of the applicant's name, dissertation title, time, date, and venue of defense two weeks prior to the defense.
- B. Final Examination
  - (1) Applicants below will give an oral presentation that is centered mainly on the insight into the research area of the dissertation (for those applicants who have withdrawn from the program but have attended for more than 3 years and have earned 12 credits. They should apply within 3 years of their withdrawal from the program will take an "exam pursuant to the final examination", however, the content will be the same as the final examination).

- (2) The final examination will be conducted by the chair of the Evaluation Committee in principle at the participating university where the chair is positioned.
- C. Evaluation of Academic Ability/Exam Exemption
  - (1) Applicants excluding those who are applying within 3 years of withdrawal, will give an oral presentation that is centered mainly on the insight into the research area of the dissertation and a foreign language written exam.
  - (2) Foreign language exam will be an English exam. However, international students can choose to take a Japanese exam instead of an English exam.
  - (3) Exams (1) and (2) above will be conducted by the chair of the Evaluation Committee at the participating university where the chair is positioned.
  - (4) Those who had enrolled in the UGSAS for 3 years or more, have received necessary research guidance, have completed prescribed credits and have withdrawn from UGSAS, and who have submitted a dissertation within 3 years after withdrawal, are exempted from English Exam.
- D. Reporting of the Evaluation Results
  - The chair of the Evaluation Committee, in consultation with the deputy chairs, will submit "Dissertation Evaluation Results" form (Form No. 8), "Results for Evaluation of Academic Ability" form (Form No. 10) or "Final Examination Results" form (Form No. 9), and Dissertation Content Summary to the Dean.
  - (2) Based on the evaluation results report, the Committee of Professors will complete the dissertation evaluation and evaluation of academic ability within one year of the acceptance of the dissertation if the applicant is applying for a Dissertation Doctorate.
- E. Final Decisions for Conferral of Degrees
  - (1) To determine the conferral of degrees, the Dean will assemble a Committee of Professors and discuss about the Dissertation Evaluation Results, Results for Evaluation of Academic Ability or Final Examination Results, and Dissertation Content Summary, from the Evaluation Committee.
  - (2) The final decision of the conferral of degrees will be decided by ballot at the Committee of Professors. 3/4 or more of the members present must approve to pass.
  - (3) The Dean will report the results of the Committee of Professors' final decisions concerning the conferral of degrees to the President of Gifu University.

#### B. Publication of Dissertation


- (1) Those who have been awarded a Ph.D. degree must publish their dissertations on the Gifu University Institutional Repository within 1 year of receiving the degree. However, this is not necessary if the dissertation has been published officially before receiving the degree.
- (2) The dissertation should be specified as "Ph.D. Dissertation Evaluated by Gifu University" if published.


